## ■ Inserting the Battery Pack



① Reverse the computer, then press and hold the **PUSH** mark part (A).

② Slide and remove the cover.

③ Insert the battery pack (B) until it securely fits the connector.

④ Slide the cover back.

### ■ To remove the battery pack

In step ③ above, slide and hold the latch (C), and pull the tab (D) of the battery pack.

#### CAUTION

- Make sure the cover is securely attached. Otherwise the battery pack may fall when you carry the computer.

#### NOTE

- Note that the computer consumes electricity even when the computer power is off. If the battery pack is fully charged, the battery will fully discharge in the following period of time:

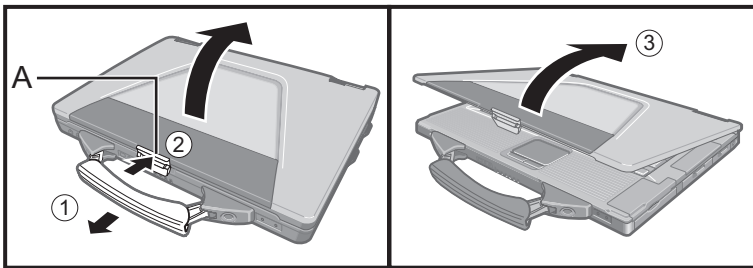

At the time of purchase, "Wake Up from LAN" is enabled.

If "Wake Up from LAN" is disabled, the period of time in sleep will become slightly longer, and the period of time in hibernation will become about the same as during power-off.

- When the DC plug is not connected to the computer, disconnect the AC cord from your AC wall outlet. Power is consumed simply by having the AC adaptor plugged into an electrical outlet.

## ■ Opening the Display



- ① Pull the carrying handle forward.

- Place the computer on a flat stable surface. Do not place the computer upright or turn it over. If the computer is exposed to an extremely strong impact, it may become inoperable.
- Temperature:

Operation	: 5 °C to 35 °C {41 °F to 95 °F}
Storage	: -20 °C to 60 °C {- 4 °F to 140 °F}
- Humidity:

Operation	: 30% to 80% RH (No condensation)
Storage	: 30% to 90% RH (No condensation)

Even within the above temperature/humidity ranges, using for a long time in an extreme environment will result in the product deterioration and will shorten the product life.

- Do not place the computer in the following areas, otherwise the computer may be damaged.
  - Near electronic equipment. Image distortion or noise may occur.
  - In extremely high or low temperature.
- As the computer can become hot during operation, keep it away from items that are sensitive to heat.

## Handling Cautions

This computer is designed to minimize shock to parts such as the LCD and the hard disk drive and equipped with a drip-proof keyboard, but no warranty is provided against any trouble caused by shock. Be extremely careful when handling the computer.

- When carrying the computer:
  - Turn off the computer.
  - Remove all external devices, cables, PC Cards and other protruding things.
  - Remove a disc in the CD/DVD drive.
  - Do not drop or hit the computer against solid objects.
  - Do not leave the display open.
  - Do not grip the display part.
- Do not put anything (e.g., a piece of paper) between the display and keyboard.
- When you board an airplane, take the computer with you and never put it in your checked luggage. When using the computer on airplane, follow the airline's instructions.
- When carrying a spare battery, put it in a plastic bag to protect its terminals.
- The touch pad is designed to be used with a finger tip. Do not place any object on its surface and do not press down strongly with sharp-pointed or hard objects that may leave marks (e.g., nails, pencils and ball point pens).
- Avoid any harmful substances such as oil from getting into the touch pad. The cursor may not work correctly.
- Be careful not to drop down or get hit when carrying the computer.

- When using peripheral devices

Follow these instructions and the Reference Manual to avoid any damage to the devices. Carefully read the instruction manuals of the peripheral devices.

- Use the peripheral devices conforming to the computer's specifications.
- Connect to the connectors in the correct direction.
- If it is hard to insert, do not try forcibly but check the connector's shape, direction, alignment of pins, etc.
- If screws are included, fasten them securely.
- Remove the cables when you carry the computer. Do not pull the cables forcibly.

## ■ Preventing your computer from unauthorized use via wireless LAN/Bluetooth/Wireless WAN

<Only for model with wireless LAN/Bluetooth/Wireless WAN>

- Before using wireless LAN/Bluetooth/Wireless WAN, make the appropriate security settings such as data encryption.

# Handling and Maintenance

## Maintenance

### To clean the LCD panel

- Do not use water to clean the panel. Ingredients included in water may leave scratches and reduce readability of the screen.
- To remove dust or dirt, do not use a cloth to rub it off since it may leave scratch on the screen. Use a fine brush to sweep dust or dirt, then wipe with a dry soft glass-cleaning cloth.
- To clean the oily surface, use a soft gauze dipped in camera lens cleaner, and then wipe with a dry soft glass-cleaning cloth.

### To clean areas other than the LCD panel

Wipe with a soft dry cloth such as gauze. When using detergent, dip a soft cloth in water-diluted detergent and wring it thoroughly.

### CAUTION

- Do not use benzene, thinner, or rubbing alcohol since it may adversely affect the surface causing discoloration, etc. Do not use commercially-available household cleaners and cosmetics, as they may contain components harmful to the surface.
- Do not apply water or detergent directly to the computer, since liquid may enter inside of the computer and cause malfunction or damage.

# Reinstalling Software

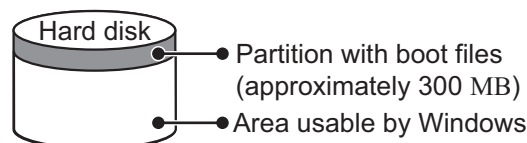
Reinstalling software will return the computer to the default condition. When you reinstall the software, the hard disk data will be erased.

Back up important data to other media or an external hard disk before reinstallation.

## CAUTION

### Windows 7

Do not delete the partition with boot files on the hard disk.  
The disk space in the partition is not available to store data.



## Preparation

- Prepare the following items:
  - The Product Recovery DVD-ROM (included)
  - Panasonic CD/DVD drive (optional)
- Remove all peripherals (except for the CD/DVD drive).
- Connect the AC adaptor and do not remove it until reinstallation is complete.

- 1 **Turn off the computer and insert the CD/DVD drive into the multimedia pocket**  
(→ *Reference Manual* “Multimedia Pocket”).
- 2 **Turn on the computer, and press F2 or Del while [Panasonic] boot screen is displayed.**  
The Setup Utility starts up.
  - If the password is requested, enter the Supervisor Password.
- 3 **Write down all of the contents of the Setup Utility and press F9.**  
At the confirmation message, select [Yes] and press Enter.
- 4 **Press F10.**  
At the confirmation message, select [Yes] and press Enter.  
Computer will restart.
- 5 **Press F2 or Del while [Panasonic] boot screen is displayed.**  
The Setup Utility starts up.
  - If the password is requested, enter the Supervisor Password.
- 6 **Set the Product Recovery DVD-ROM for Windows which you install into the CD/DVD drive.**
- 7 **Select the [Exit] menu, then select [TEAC DV-W28XXX] in [Boot Override].**
- 8 **Press Enter.**  
The computer will restart.

### Windows 7

- 9 **Click [Reinstall Windows] and click [Next].**  
The License Agreement screen appears.
- 10 **Click [Yes, I agree to the provisions above and wish to continue!] and click [Next].**
- 11 **When reinstalling Windows 7 from Windows 7:**  
Select the settings and click [Next].
  - [Reinstall Windows to the whole Hard Disk to factory default.]  
You will have two partitions.
  - [Reinstall to the first 2 partitions.]\*<sup>1</sup>  
Select this option when the hard disk has already been divided into several partitions. For how to create a new partition, refer to “To change the partition structure” (→ page 15).  
You can keep the partition structure.

\*<sup>1</sup> This does not appear if Windows cannot be reinstalled to the partition containing boot files and the area usable by Windows.

## ■ Starting Up


